Violations Comments

Violation #47. Food & non-food contact surfaces

Repair or replace a rubber gasket in one of the milk boxes located at the right side of the kitchen from the office. At time of inspection it observed in the corner a little loose. Temperature of the milk was in 41 F. This is a repeat violation.

CODE REFERENCE: 64E-11.003(4). Equipment and utensils must be properly designed, constructed, and in good repair.

Violation #51. Plumbing installed; proper backflow devices

-Repair a leak under the sink for Wash in the four compartment sink at the left side of the kitchen from the office.

-Increase the pressure in the faucet in the sanitizing sink at the left side of the three compartment sink in the kitchen and in the bathroom of the kitchen.

CODE REFERENCE: 64E-11.003(5)(c). Plumbing will be installed and maintained to comply with plumbing requirements, including backflow prevention devices. A mop sink will be provided.

Violation #54. Garbage & refuse disposal

Kept all the time lid's closed of the dumpsters outside at the back of the kitchen. Company for the garbage need to relocated the first dumpster to be able closed the lids (it observed to closed from the three and is impossible to closed).

Provide a missing drain plug at the bottom of one of the green dumpsters (second one).

CODE REFERENCE: 64E-11.003(5). Garbage shall be disposed of to prevent vector harborage. Trash cans will be durable, cleanable, leak proof, insect and rodent resistant, and non-absorbent. Outside storage area shall be of a smooth, non-absorbent material and sloped to a drain.

Violation #56. Ventilation & lighting

Replace three burned light bulbs (one and two at the front), under the hood filters system. This is a repeat Violation.

Replace a light bulb in the walk-in freezer to increase the intensity of the light. This is a repeat violation.

Attached a loose cover for the light above of the four sink for ware washing in the kitchen at the left side from the office.

Replace three burned out lights next to the ice machine (two above of the three compartment and one above of the ice machine).

CODE REFERENCE: 64E-11.003(6)(a). Adequate exhaust ventilation hood systems in food prep and warewashing areas shall be provided and designed. 50 foot candles shall be at surfaces where employees work with food and 20 foot candles shall be at surfaces where food is provided to consumers.
